Good day NTAB and PREDA Members:

As requested from the NTAB meeting last week; **Bob Gammer, BCHydro Manager** of Community Relations has agreed to provide a **tour of SiteC Dam on Saturday October 14<sup>th</sup>**.

Note: As a follow-up from your meeting.. NTAB **will not** be renting a greyhound as private vehicles are not permitted to enter the worksite.

Instead, Bob of SiteC has agreed to provide a bus shuttle in Fort St. John to bring us to the Dam. **HENCE All participants will drive themselves to Fort St. John at the meeting point below.**

- 1) The Site C Tour for NTAB / PREDA Municipal leaders will be on Saturday October 14<sup>th</sup>
- 2) Tour will be 2-hours in length. Plus ½ hour shuttle bus to/from the Site C.
- 3) SiteC will provide a shuttle bus for a **maximum of 35 persons. 1 elected official per NTAB/PREDA (designated Council representative given priority)**. We have also invited 1 representative each from our non-municipal members – CF PC; CF GP, Northwestern Polytech, and Northern Lakes College. And 1 representative from our reciprocal members – Grande Prairie Chamber of Commerce; Peace River Chamber of Commerce, and our Government of Alberta local Rep as Site C will have impact on our current businesses and future investment potential.
- 4) SiteC Shuttle bus will **Pick-up 11:30AM / Drop-off 2:00PM** at the Pomeroy Hotel & Conference Centre (11308 Alaska Road, Fort St John, BC) parking lot.
- 5) All tour participants **must** wear steel-toe boots with a 6" back; and wear a long-sleeved shirt/ coat. SiteC will provide the rest of the Personal Protective Equip. ( hard hat, high-vis vest, safety glasses)
- 6) All tour participants must have with them valid, government issued, photo ID.
- 7) I have cc'd the CAO's of all Municipal members so he/she is aware of your forthcoming request and for internal Council approval.

Please **RSVP by Friday Oct 6<sup>th</sup>** . At which time the list of participants will be sent to Bob at Site C.

ALSO: I will be out the office next week. I spot check registrations when I return on Tuesday Oct 3<sup>rd</sup>.
